Electronic Mode means tele - conferencing and / or video conferencing facility i.e. audio - visual electronic communication facility which enables all persons participating in that meeting to communicate concurrently with each other without an intermediary, and to participate effectively in the meeting.</p> <p>viii. Electronic Record means data, record or data generated, image or sound stored, received or sent in an electronic form or micro film or computer generated micro fiche;</p> <p>ix. Financial year in relation to any company or body corporate, means the period ending on the 31st day of March every year and where it has been incorporated on or after the 1st day of January of a year, the period ending on the 31st day of March of the following year;</p> <p>x. Secretarial Standards means the secretarial standards as applicable for the time being in force, as issued or notified by way of Notification by the Institute of Company Secretaries of India (ICSI) constituted under Section 3 of the Company Secretaries Act, 1980 (56 of 1980) and approved by the Central Government.</p> <p>xi. Minutes book means a book maintained in physical or in electronic form for the purpose of recording of Minutes.</p>

xvi. PRIVATE LIMITED COMPANY

The Company is a Private Limited Company within the meaning of sub section (68) of Section 2 of the Companies Act, 2013 and accordingly:

private company means a company which by its articles

(i) restricts the right to transfer its shares;

(ii) limits the number of its members to two hundred:

Provided that where two or more persons hold one or more shares in a company jointly, they shall, for the purposes of this clause, be treated as a single member:

Provided further that

(A) persons who are in the employment of the company; and

(B) persons who, having been formerly in the employment of the company, were members of the company while in that employment and have continued to be members after the employment ceased, shall not be included in the number of members; and

(iii) prohibits any invitation to the public to subscribe for any securities of the company;

xvii. Special Business means a business other than the Ordinary business to be transacted at an Annual General meeting and all business to be transacted at any general meeting.

xviii. These Articles or Regulations means this Article of Association as originally framed or altered from time to time and includes the Memorandum where the context so requires.

xix. Video conferencing or other audio visual means audio visual electronic communication facility employed which enables all the persons participating in a Meeting to communicate concurrently with each other without an intermediary and to participate effectively in the Meeting.

xx. Writing and Written shall include printing, lithography and any other mode or modes of representing or reproducing words in visible form.

xxi. The marginal notes here shall not affect the construction thereof.

xxii. Words imparting the singular number include, where the context admits or requires, the plural number and vice versa.

xxiii. Words imparting the masculine gender also include feminine gender.
